Terms and Conditions

1. The Promoter is Lendlease Property Management (Australia) of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (**Lendlease**). Contact number is 08 9404 9013.
2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
3. The following person(s) are ineligible to enter the Competition:
 - (a) employees of:
 - (i) any retailer within Northgate Shopping Centre;
 - (ii) the Promoter; and

References in these terms and conditions to the Competition Period include any Extended Competition Period, where applicable.
5. The prize is a Northgate Voucher valued at a maximum of \$250 AUD (**Prize**). The value of each voucher is \$250 AUD and the total prize pool is valued at \$500.
6. To enter you must spend a minimum of \$50 in one transaction at any Participating Retailer (refer to clause 11 for list of non-participating retailers), write your name, address and telephone number on your receipt and enter it into the box near Target.
